- The material does not contain substances subject to restrictions as per the above-mentioned laws and complies with global migration limits under the following conditions
- The material contains substances subject to restrictions as per the above-mentioned laws. The material complies with global migration limits and specific restrictions under the following test conditions:

simulant A: distilled water,  
simulant B: 3% acetic acid in aqueous solution,  
simulant C: 15% ethanol in aqueous solution,  
simulant D: rectified olive oil  
under test conditions: 40 °C for 10 days.

Based on the results of these tests, the product is suitable for contact with foodstuffs for which migration tests are provided in simulants A, B, C and D, in accordance with the provisions of Directive 85/572/CEE and Directive 82/711/CEE, at room temperature or below for an unspecified period of time.

The product could contain the following substances for which an SML has been determined:

- EC:74880 - CAS: 84-74-2 - SML=0,3 mg/kg (impurity)
- EC:68320 - CAS: 002082-79-3 - SML=6 mg/kg
- EC:39090 - CAS: 071786-60-2 - SML=1,2 mg/kg
- EC:38820 - CAS: 026741-53-7 - SML=0,6 mg/kg
- EC:19960 - CAS: 000108-31-6 - SML=30 mg/kg

Based on experimental data and/or theoretical calculations, the content of these substances conforms to the provisions of European Regulation 10/2011 and the Ministerial Decree of 21 March 1973.

The global migration limit, along with other specific restrictions to which the monomers and/or additives present in the material may be subject, are respected under the above-mentioned conditions of use. This statement is supported by analytical tests performed in accordance with Directives 82/711/CEE and 85/572/CE and the Ministerial Decree of 21 March 1973.

4) The material may contain substances regulated by Directives 89/107/CE and 88/388/CE and by Ministerial Decrees 209 of 27 February 1996, 684 of 27 November 1996, and of 23 July 2003 (so-called dual use substances). According to experimental data and/or theoretical calculations, these substances comply with the provisions of Art. 11 Regulation 10/2011/CE and Art. 9 paragraph 2, letter c) of the Ministerial Decree of 21 March 1973. The user of the material intended to come into contact with foodstuffs is responsible for advising Colombino & Polano of any restrictions in terms of composition (presence of additives and flavorings) for the foodstuff to be packaged.
